Served on Dewey council with honesty, integrity, strong morals and work ethic. Will work hard to maintain a fair balanced approach to promote the town and to protect its character and quaintness. Pledge to uphold the requirement of the Town Charter and uniform enforcement of our present Code.

MY CONCERNS IN DEWEY BEACH AND MY PLANS TO MAKE IT BETTER:

Transparency: Open and honest government creates trust. Too many things are done without public knowledge and behind closed doors... The Freedom of Information Act sets guidelines for government actions. We can do better informing the public of council's intentions. We need shorter more efficient town meetings. **Important issues absolutely need to go to referendum**

Expired Town Official Contracts: Contracts need to be in place. The town manager's contract expired February 2015 and our Chief of Police contract expired December of 2014. Working without contracts promotes liability.

Budget Committee: Reinstate budget & finance committee to ensure financial oversight by property owners. The budget committee was disbanded under the current administration. Re-instating the budget committee which is in place in most Delaware towns would be a WIN-WIN for the Town. Grant money is available but not being applied for.

Constitutional Rights/Inspections: I filed a complaint with the ACLU to protect YOUR constitutional rights of privacy because ordinance 423 (enacted 2000) and the license application violates the Constitution by allowing unwarranted inspections. The town has been told by the ACLU the ordinance is illegal and they must rescind and remove it from the rental application. As your commissioner, I will work to ensure your rights are always protected and that applications and our town code are compliant with federal and state laws.

Investment Policy: My record indicates a very conservative approach to investing public monies. I believe the current investment policy is too aggressive, as reported this year by the Audit Committee and audit firm. Management of investments needs to stay within the State.

Town Flooding: I support a comprehensive approach to dealing with flooding on the entire bayside not a piece meal approach to this problem. I will work with federal, state and county legislators on your behalf.
